# Sauk-Suiattle Indian Tribe Job Description

Job Title: Tribal Archaeologist

Department: Cultural Resources Department (CRD)

Reports To: CRD Director

Status: Exempt, part-time to expand to full time

SUMMARY: The Tribal Archaeologist works with various Departments and Programs within the Sauk Suiattle Indian Tribe - Cultural Resources: Natural Resources; Tribal Historic Preservation Officer; Tribal Cultural Preservation Coordinator: Office of Legal Counsel and the Tribal Council. The Tribal Archaeologist will work specifically with the THPO and the Tribal Council assigned Cultural Historic Preservation Committee. Acts as the Principal Investigator, under the supervision of the Tribal Historic Preservation Officer (THPO) located within the Cultural Resource Department (CRD), to provide professional and technical assessments within the field of archaeology, either alone or with other CRD staff, to the Sauk-Suiattle Indian Tribe, as well as to public and private proponents, concerning compliance with the National Historic Preservation Act of 1966, the National and State Environmental Policy Acts, and other State and Federal laws protecting cultural resources and archaeological properties on the Reservation, on traditional lands of the Sauk-Suiattle Indian Tribe, or in common use areas. Provide technical assistance in the identification of cultural resources, cultural resources sites, and areas of significance to the Sauk-Suiattle Indian Tribe. either alone or with a field crew. Perform or work with CRD staff in the performance of cultural resources inventory surveys and subsurface investigations, when needed; anywhere CRD cultural resources projects are to be carried out. Keep detailed records assuring completeness and accuracy of activities carried out in the field. Including filling out forms, keeping project or site notes, and supervising a crew in filling out required records as needed. Ensure that fieldwork is carried out in an efficient, professional manner. Track artifacts that have to undergo laboratory analyses. Keep field equipment clean and in working order. Work actively with government officials, tribal members, cultural resource professionals, and property owners to mitigate project impacts to cultural resources and archaeological resources significant to the Tribe, State, and Nation.

**Essential Duties and Responsibilities** include the following. Other duties may be assigned.

 Under the direction of the Tribal Historic Preservation Officer, act as the Principal Investigator to implement cultural resources projects, alone or with CRD staff.

- Primarily, this consists of archaeological site inventories, filling out forms and field reports and records;
- Work with CRD staff to conduct research and identify inventories of areas important to the Sauk-Suiattle Indian Tribe. Inventories shall consist of: file and literature searches and their interpretation, oral history interviews, field reconnaissance of cultural resource sites, updates of previously recorded cultural resource sites, and the recording of new sites and isolates. Formulate research design and conduct or work with CRD staff to conduct field testing which may include subsurface testing, as warranted:
- Coordinate field crews during cultural resources surveys or subsurface testing to carry out their work in a professional manner; that is surveying or excavation of proscribed manner and filling out forms and keeping records. Ensure that field crews act in a manner that is credit to the Sauk-Suiattle Indian Tribe at all times;
- Prepare and work with CRD staff in the preparation of reports. Ensure that forms and records are complete and clearly written so the report writer can easily read and interpret them;
- Evaluate proposals for construction activities that could include the discovery, disturbance, excavation or removal of cultural or archaeological resources; make recommendations to the Tribal Historic Preservation Officer and project proponents regarding these proposals;
- Evaluate environmental documents and survey reports prepared by others pursuant to State and Federal statutes to ensure that they meet Federal historic preservation program standards and the needs of the Tribe;
- Monitor and/or work with CRD staff in the monitoring of construction contract activities relating to cultural and archaeological resources;
- Support and assist the THPO in duties and functions as needed;
- Assist the THPO in the development of CRD policies, guidelines, MOUs, MOAs, and Office Manual;
- Interact pro-actively with government officials, tribal members, cultural resource professionals, and project proponents so that project planning occurs efficiently and effectively, cultural resources are protected, and project impacts to archaeological resources are mitigated and/or minimized;
- Oversee the storage of and maintenance of all field equipment such as: screens, shovels, trowels, tapes, survey pins. Ensure that the equipment is cleaned after field work, repaired or replaced if broken, and stored such that it is accessible to CRD staff and others;
- Provide information and training to inform and educate Tribal officials and others in the theory, practice, and legal foundation of cultural resource management.
- Assisst the CRD Tribal Cultural Properties Coordinator in establishing tribal sacred and culturally protected sites through a management system using GIS Mapping.
- Assist the CRD Language Program in mapping identified traditional names of landscape, plants, and locations to be used in curricula development.
- Assist Education Programs with STEAM/STEM based programs developed for the benefit of our tribal community youth.
- Assist Cultural Resources in bringing together proper documentation to help develop mitigation cases for natural, subsistence, and cultural resource concerns facing the Sauk Suiattle Indian Tribe broadly such as the Shell Fish Rights and Hunting Rights.

**QUALIFICATIONS:** To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Must meet the Secretary of Interior standards for a Professional Archaeologist.
- Knowledge of the broad field of cultural resource management as it is reflected in Federal and State laws, regulations, and policies; the science and practice of archaeology generally and the Pacific Northwest particularly.
- Ability to apply established program standards in all areas of the Tribe's Cultural Resources Management Program specifically the archaeology service portion; communicate effectively orally and in writing the Tribe's position regarding archaeological matters; and maintain creditable working relationships with program clients.
- Ability to work nights, weekends, holidays, during an emergency inadvertent discovery.

# **Education and Experience**

Master's Degree in Archaeology and a minimum of 3 years of related work experience including a strong background in Section 106 and the implementation and experience of consultation with Indian Tribes or federal agencies.

#### Language Skills:

Ability to read, analyze, and interpret common scientific and technical journals, financial reports, and legal documents. Ability to work in a native community and be open to cultural interpretations and traditions. Ability to consult with federal, state, and private agencies concerning Cultural Resource management. Ability to respond to common inquiries or complaints from customers, regulatory agencies, or members of the business community. Ability to write speeches and articles for publication that conform to prescribed style and format. Ability to effectively present information to top management, public groups, and/or boards of directors.

#### **Mathematical skills**

Ability to apply advanced mathematical concepts such as exponents, logarithms, quadratic equations, and permutations. Ability to apply mathematical operations to such tasks as frequency distribution, determination of test reliability and validity, analysis of variance, correlation techniques, sampling theory, and factor analysis.

Ability to apply principles of logical or scientific thinking to a wide range of intellectual and practical problems. Ability to deal with non-verbal symbolism
